



## Information for returnees from Austria

July 2018

### WHAT IS ERRIN?

The European Return and Reintegration Network (ERRIN) is a joint reintegration program of several European member states. The main purpose is reintegration assistance to third country nationals after their return to the country of origin.

Austria is an official ERRIN partner since June 2016.

### COUNTRIES IN WHICH YOU CAN RECEIVE ERRIN SUPPORT:

- **Bangladesh**
- **India**
- **Iraq Central**
- **Iraq KRG**
- **Morocco**
- **Pakistan**

### CAN YOU PARTICIPATE?

You can participate in the ERRIN program if you are coming from one of the listed countries.

The final decision will be made by the Austrian Federal Office for Immigration and Asylum (BFA). You will receive more information about the specific participation requirements from the return counselor (see further information on ERRIN application and assistance process).

Only one person per nuclear family is eligible to participate.

### WHAT KIND OF SUPPORT CAN YOU RECEIVE?

- **Counseling** on opportunities and options based on the local situation, your educational and professional background and your life situation.
- **Financial assistance:** Cash grant of **€ 200** to address most immediate needs after arrival to your country of origin.
- **In-kind assistance** in the amount of **€ 2.800**, depending on your individual plans and needs (**NOT IN CASH!**).
- Temporary housing
- Medical and social assistance
- Administrative and legal assistance
- Small business start-up assistance
- Educational or vocational trainings

## ERRIN APPLICATION AND ASSISTANCE PROCESS

---

### Step 1: Consultation with the return counselor

In order to be able to apply for the ERRIN program you need to have a consultation with one of the return counseling organizations:

The return counselor will assist you with filling in the ERRIN application form and provide you with all the necessary information about the process.

### Step 2: Confirmation of participation and preparation for return

After the approval of your application by BFA (the application will be sent by the return counseling organization) your return counselor will help you with the organization of travel logistics (including purchase of flight ticket by IOM, ID-documents).

### Step 3: Departure to your country of origin

When needed, the return counseling organization will bring you to the Vienna International Airport where you will receive departure assistance by the International Organization for Migration (IOM). You will also be assisted by IOM in transit areas (if you have a stop-over).



### Step 4: Start of the reintegration process

Before your departure you will be given the contact details of the ERRIN partner organization in your country. Please contact that organization straight after your return.

The ERRIN partner organization can also be contacted before the return, mainly through the return counseling sessions. If you have further questions afterwards you can also contact the organization by yourself.

During the first meeting with the ERRIN partner organization in your country you will receive information about further steps in your reintegration process and the delivery of reintegration support will start.
